

**CITY OF PLAINFIELD
SPECIAL CITY COUNCIL MEETING
March 30, 2026
6:15pm**

The Plainfield City Council met in special session on March 30, 2026, in the Council Chambers of City Hall at 6:15pm with Mayor Thomas Geise presiding and Council Members Clyde Balvanz, Jamison Downing, Joseph Schmall, and Chad Shurtleff present. Council member Timothy Neil was absent. City Clerk Abigail Miller was also in attendance.

Mayor Geise opened the public hearing concerning Ordinance No. 59: AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF PLAINFIELD, IOWA, BY AMENDING PROVISIONS PERTAINING TO SEWER SERVICE CHARGES REQUIRED AND RATES at 6:16pm. Mayor, Council, and department heads reviewed the proposed rate increase and verified that it matches 100% water rate increase. No comments were received from the public. Motion by Schmall, seconded by Shurtleff to approve the second reading of Ordinance No. 58: AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF PLAINFIELD, IOWA, BY AMENDING PROVISIONS PERTAINING TO THE WATER SERVICE SYSTEM, WATER METERS, AND RATES FOR WATER SERVICE. Roll call vote- Ayes: Balvanz, Downing, Shurtleff, and Schmall. Nays: None. Absent: Neil. Motion carried.

Motion by Shurtleff, seconded by Balvanz to set the date/time of the Adoption of FY27 Budget & Certification of City Taxes on Tuesday, April 14, 2026, at 6:00pm in the Council Chambers of City Hall, 604 Main Street, Plainfield. Ayes: All. Motion carried.
